2024 Robert L. Gernon Award for Outstanding Service to Continuing Legal Education in Kansas

David J. Rebein, Dodge City

David J. Rebein, Dodge City, is a recipient of the 2024 Robert L. Gernon Award presented by the Kansas Continuing Legal Education board.

Each year, it is an exercise in gratitude and appreciation as Kansas CLE board members gather to review the nominations that are received. This year, the board considered an impressive slate of candidates, varying from attorneys in private practice to those law firms and associations who offer CLE as a benefit to their members. After much deliberation, the board determined that, for the first time in the history of the award, Kansas CLE would select two very qualified recipients for the 2024 Robert L. Gernon Award for Outstanding Service to Continuing Legal Education in Kansas: Joseph, Hollander and Craft, a CLE provider and law firm in Kansas, and David J. Rebein, an attorney in Dodge City, Kansas.

David Rebein is known for his generous contributions to the legal profession and his community in southwestern Kansas. He is a nationally recognized trial lawyer and a past president of the Kansas Bar Association. This award recognizes Mr. Rebein's continued commitment and dedication to the legal profession by creating, spearheading, and presenting continuing legal education opportunities throughout rural western Kansas, many times at his own expense. He has shared his experience and expertise by presenting at many programs hosted by CLE providers across the state, including the Southwest Kansas Bar Association and Ellis County Bar Association. He has arranged numerous educational opportunities throughout the region, like his 21st Century Country Lawyer, Ethics CLE program.

In his nomination letter, attorney Pablo Mose, wrote, "this nomination reflects David Rebein's unique commitment to providing continuing legal education in Kansas and focusing on aid to Kansas lawyers in rural areas. On his own accord, beyond his rural justice committee involvement, David hosted multiple meetings in rural areas in western Kansas to reach local lawyers in smaller, in-person groups. He represents the heart of rural legal practice in Kansas, and his top priority in life is to help uplift, unite, and serve rural lawyers in Kansas."

The Kansas CLE Board recognizes and appreciates the efforts and commitment to continuing legal education of all lawyers in Kansas. Mr. Rebein's contributions to CLE in the rural areas of the state, and beyond, are commendable. His enthusiasm for continuing legal education, promoting the importance of educating and sharing information with his peers, and his endless dedication to the legal profession explains why he was chosen as one of the award recipients this year.

2023 -Angela Gupta, Lake Quivira



Angela Gupta, Lake Quivira, is the 2023 recipient of the Robert L. Gernon Award presented in December by the Kansas Continuing Legal Education board.

Gupta is a mediator, arbitrator, and independent investigator with Associates in Dispute Resolution. She was nominated for the award by the Association for Women Lawyers of Greater Kansas City.

In the letter nominating her, which was accompanied by many endorsements from her Kansas-licensed peers, the association highlighted the impact Gupta has had on the legal profession in Kansas and Missouri.

Carrie Reid, the association's awards co-chair, wrote in the nominating letter that Gupta is the kind of member associations are proud to have.

"She is continually giving back, ensuring that the future of the legal profession continues to be held to the high standard the community at large expects," Reid wrote.

Larry Rute, who works with Gupta at the Associates in Dispute Resolution, was among the colleagues to endorse her nomination.

"Angela has proven to be a distinguished leader in organizing, developing, and presenting high-quality continuing legal education presentations," Rute wrote.

Rute added that Gupta's accomplishments as a bar leader demonstrate an incredibly impressive background of continuing legal education support and involvement.

Danielle Atchison of the Mdivani Corporate Immigration Law Firm praised both the subject matter and quality of Gupta's continuing legal education courses. She noted the dispute resolution topics Gupta presents "are so important that our law schools are creating specific emphasis opportunities in dispute resolution."

Gupta is a graduate of the University of Pennsylvania and the University of Kansas School of Law.

2022 – Jared Scovel Maag, Topeka



Jared Maag, Topeka, is the 2022 recipient of the Robert L. Gernon Award presented by the Kansas Continuing Legal Education Board.

Maag is an Assistant U.S. Attorney for the District of Kansas. He was nominated by the Women Attorneys Association of Topeka. In their nomination letter, they highlighted the importance of Maag's continuing education programs.

"Maag's presentation is often a favorite in the Topeka area, as it is an entertaining and easy way for attorneys to stay up to speed on the U.S. Supreme Court decisions and their impact," the Women Attorneys Association of Topeka wrote in their nomination letter. "Considering the length and import of many U.S. Supreme Court decisions, getting a concise breakdown of the most recent decisions allows attorneys to know what

decisions may affect their area of practice, as well as generally staying up to speed on the status of important constitutional issues."

Maag said he believes continuing legal education is one of the most important parts of being a practitioner.

"Our profession demands that we be able to advocate with a full understanding of the law that is relevant to the subject at hand," Maag said. "It is vital that we are provided a wide array of continuing legal education topics that will address emerging issues in the law as well as topics that impact our daily lives as attorneys, namely, mental health and wellness concerns."

He began presenting continuing legal education programs over a decade ago to share his love of the U.S. Supreme Court. "I love the tradition of the court, the history, the stories, and the justices who have served the institution," Maag said. "Being able to provide others with yearly updates on what is happening at the court is something I look forward to with almost childish glee."

Maag said receiving this award was very meaningful to him. He had the honor of arguing in front of Gernon when he served as deputy solicitor general, and Gernon corresponded with him while he was deployed on active duty. Maag recalls having wonderful conversations about international issues and what Maag observed during his tour of duty. "It is hard to put into words how meaningful those conversations were," said Maag. "It eased my time away from family and friends."

Maag served as a judge advocate for the U.S. Army and Kansas National Guard for nine years, including one year as judge advocate for the joint military affairs team in Bosnia and Herzegovina.

He graduated from Air Command and Staff College, Air War College, The American University School of International Service, and Washburn University School of Law. After graduating from law school, he served as deputy solicitor general for 14 years. He currently serves as senior judge advocate for the Kansas National Guard, staff judge advocate for the Kansas Air National Guard, adjunct professor of law at Washburn University School of Law, and assistant U.S. attorney.

Maag is a past president of the Sam A. Crow Inn of Court and a member of the American Bar Association, Kansas Bar Association, and Topeka Bar Association.

2021 – The Honorable Karen Arnold-Burger, Topeka



Karen Arnold-Burger, chief judge of the Kansas Court of Appeals, is the 2021 recipient of the Robert L. Gernon Award presented by the Kansas Continuing Legal Education Board.

Established in 2005, the Gernon Award recognizes individuals or organizations demonstrating a unique commitment to legal education for lawyers in Kansas and for providing outstanding service to continuing legal education.

Arnold-Burger was nominated by the Kansas Women Attorney's Association, the Women Attorneys Association of Topeka and Chief Justice Marla Luckert. In the nomination letters, all highlighted the impact Judge Arnold-Burger has had on the legal profession in Kansas.

"Chief Judge Arnold Burger has a gift for engaging all of these audiences, delivering her educational tonic in the most entertaining way, as evidenced by the near constant demand for her appearances," Luckert said in her nomination.

Arnold-Burger has presented over 118 continuing legal education and continuing judicial education programs in the past 10 years, the Women Attorneys Association of Topeka said in its nomination.

"As lawyers and judges our lives are so busy," Arnold-Burger said. "Continuing legal education really forces us to stay up-to-date in our substantive areas of law and reminds us of the importance of ethical behavior.

Arnold-Burger also mentioned that she enjoys finding topics that fit into the "we don't know what we don't know," category, and that she loves seeing lawyers and judges experience that "aha" moment.

Arnold-Burger graduated with a degree in political science and psychology from the University of Kansas in 1979 and from the University of Kansas School of Law in 1981. She was a municipal court judge for 20 years in Overland Park before joining the Kansas Court of Appeals in 2011.

She has served as president of the Kansas Municipal Judges Association, Earl E. O'Connor Inn of Court, and the Johnson County Bar Association, as well as a member of the American Bar Association, University Kansas School of Law Board of Governors, and the National Judicial College Faculty Council.

Justice Robert Gernon served on the Kansas Supreme Court from 2003 until his death in 2005 and previously on the Kansas Court of Appeals from 1988 to 2003. He worked to improve the training, education, and professionalism of attorneys in Kansas and across the nation.

"Judge Arnold-Burger inspires us all to be better," said the Kansas Women Attorneys Association in its nominating letter. "She lives up to Justice Gernon's memory and the standards he set for us all."

2019 – Laura Shaneyfelt, Lawrence



Laura Shaneyfelt, Lawrence, Kansas, has been selected by the Kansas Continuing Legal Education Commission as the recipient of the 2019 Robert L. Gernon Award.

Laura Shaneyfelt is CJA Resource Counsel with the Kansas Federal Public Defender Office.

Shaneyfelt was nominated by the Kansas Federal Defender Office. In their nomination letter, they highlighted the impact that Shaneyfelt has had on the legal profession in Kansas. “In just a few years, Laura has turned our office into a model training provider for federal defenders, state defenders, private criminal-defense counsel, and others.” In addition, Shaneyfelt has presented CLE programs around the state and country on a variety of topics and continues to work to improve and support the Kansas bar.

Shaneyfelt received her Bachelor of Science in Journalism from Kansas State University in 1982, and her Juris Doctor from the University of Kansas School of Law in 1985. She practiced law for 30 years in Wichita, Kansas before joining the Kansas Federal Defender Office in 2014. Stephen Angermayer, Pittsburg, Kansas, has been selected by the Kansas Continuing Legal Education Commission as the recipient of the 2018 Robert L. Gernon Award.

Stephen Angermayer is an attorney with the firm of Fern and Angermayer in Pittsburg, Kansas.

Angermayer was nominated by John Mazurek and by Michael Gayoso of the Crawford County Attorney's Office. In his nomination letter, Gayoso highlighted the impact that Angermayer has had on the legal profession in the southeast area of Kansas. "He took it upon himself to organize monthly one hour continuing legal education (CLE) luncheons, although he was and is not on the board. Living in Southeast Kansas, it is difficult to obtain quality CLE's on a consistent basis and Steve strives to achieve this every month." David E. Pierce is a Professor of Law at Washburn University School of Law in Topeka, Kansas. He currently teaches Oil and Gas Law, Advanced Oil and Gas Law, Energy Regulation, and Drafting Contracts and Conveyances. Professor Pierce received his B.A. from Kansas State College of Pittsburg in 1974 and his J.D. from Washburn University School of Law in 1977. Then in 1982, he received his LL.M. from University of Utah College of Law. He began his career as a solo practitioner in Neodesha, Kansas. He then worked in-house for Shell Oil Company in Houston Texas, Gable & Gotwals law firm in Tulsa, Oklahoma, and Shughart Thomson & Kilroy law firm in Kansas City, Missouri.

Professor Pierce was nominated by John W. Broomes of the Hinkle Law Firm, LLC, and Timothy E. McKee of the firm, Triplett Woolf Garretson, LLC. 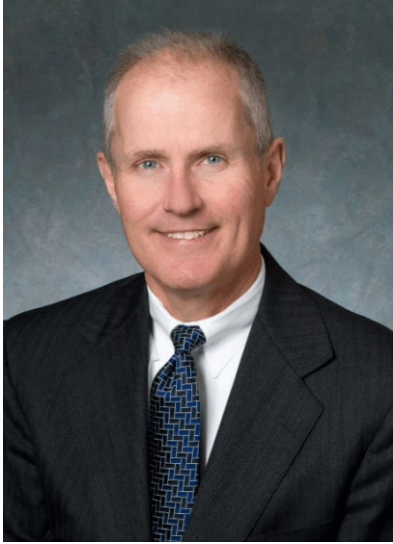

In addition, he has organized the annual recreational law CLE for the Kansas Bar Association at Flint Oaks in Elk County. Judge Schmisser believes in the social aspect of continuing education. Judge Schmisser may perhaps be most well known as the host of the annual Ski CLE event. He organizes the CLE programming for the Ski CLE and related social events almost single-handedly, devoting hours of time to every detail each year. In visiting with Judge Schmisser about the Ski CLE, you will quickly discover that he believes that the value of this CLE program lies not only in the substantive legal information shared with the participants, but also, and perhaps more importantly, in the interaction that occurs between the attorneys in attendance. Judge Schmisser recently stated, “Lawyers don’t socialize enough with their peers. If they get to know each other better, they try harder to resolve a case before going to trial. By doing so, the lawyers create a more civil, more efficient and more economical use of the judicial system.”

He was awarded the Kansas Bar Association’s Outstanding Service Award in 1997 and the Southwest Kansas Bar Distinguished Service Award in 2006. In addition, the local school district awarded Judge Schmisser with the Friends of the Education award for his work with high school students.
